

**PERMISSION TO AN INDIVIDUAL FOR RIGHTS TO PUPIL RECORDS AND/OR RIGHTS TO MAKE EDUCATIONAL DECISIONS  
(NOT FOR USE IN GRANTING RIGHTS TO AGENCIES)**

Rights to Records: A Parent/Legal Guardian may provide permission to a third party, such as a step-parent or grandparent, to be given the Rights to Records over a student in order for the third party to receive that student’s educational records, in written or oral format. I understand that by delegating the ability for the designated third party to receive pupil records, the individual may receive my child(ren)’s progress, behavioral, and student health records.

Parent Portal Access: A parent/legal guardian may also delegate authority to a third party to have access to the District’s parent portal system. Parent portal access includes such items as attendance records, grade reports, student schedules, and access to meal account balances and the ability to deposit funds into meal accounts. In order to grant parent portal access, a parent/legal guardian must provide permission to the individual for rights to records. Absent granting rights to records, parent portal access cannot be given.

Rights to Make Educational Decisions: A parent/legal guardian may also delegate authority to a third party to make educational decisions for that student. Educational decisions include such items as signing up for conferences, granting permission for student to attend school activities, communicating with the teacher and/or school, and assignment of courses. The Rights to Make Educational Decisions does not grant the responsibility for truancy, discipline, payment of fees, medical services, immunizations, enrollment, in-district transfer requests, report cards, or specialized educational services. In addition, the Rights to Make Educational Decisions does not change the Parent’s/Legal Guardian’s rights to the student and the Parent/Legal Guardian shall remain responsible for all school related issues.
