

PARENTAL CONSENT AND AGREEMENT FOR FOREIGN OR DOMESTIC TRAVEL

We, the undersigned parents or guardians of _____ agree to the following as a condition of granting permission for our son's/daughter's participation in the District-sponsored or authorized trip to _____ from _____ 20__ to _____, 20_____:

1. Our son/daughter has our permission and consent to participate in the above-specified student trip. We have been advised of the details of the trip, including its itinerary, homestays and their duration if any, transportation arrangements, and lodging (if applicable), and agree to same.
2. Our son/daughter will be bound and abide by the District's Student Trip Policy (attached hereto) and other related School District rules. We have read and reviewed the District's policy with respect to student trips with our son/daughter.
3. Our son/daughter will be under the charge and supervision of School District approved chaperone while on the trip. We recognize and approve of the fact that, when homestays are announced and included in the trip plan, the student will not be under the immediate supervision of the chaperone at all times. The chaperone will be within the country of the homestay and will clearly instruct all students concerning how he/she can be contacted. These chaperones may take whatever action they deem necessary to ensure compliance with the Student Trip Policy and other School District rules.
4. Our son/daughter has health insurance coverage. The School District chaperones on the trip may authorize medical care and treatment for our son/daughter should this become necessary while on the trip. If such care or treatment should become necessary, we will be notified by School District officials of this fact as soon as is reasonably possible.
5. If applicable, our son's/daughter's hotel room(s) or other lodging may be inspected at any time to ensure compliance with the terms of the Student Trip Policy and other District Rules.
6. If our son/daughter engages in any behavior in violation of the Student Trip Policy or other School District rules, our son/daughter may be sent home immediately at our expense. If it becomes necessary to send our son/daughter home, we understand that we will be notified of this fact by School District officials and may be asked to transport our son/daughter home. On the trip home, we understand that our son/daughter may not be accompanied by a District employee or provided other supervision.
7. We waive any damages and will hold the Rice Lake Area School District, its agents and employees, harmless from any damages or liabilities, including indemnification, arising whatsoever, in any action or proceeding brought by ourselves or on behalf of our son/daughter, or by a third party relating to acts of our son/daughter, based upon any and all acts and events occurring during the trip.
