We offer 6th, 7th and 8th grade Middle School students a few a la carte choices during part of their lunch time. A la carte items are **NOT** part of the lunch program. **Students will not be able to purchase a la carte items without a parent signed A la Carte Permission Form. An additional entrée from the lunch program is consider a la carte.**

*****PLEASE NOTE***** If you fill out a form this year for your son or daughter allowing them to make a la carte purchases you will not need to fill it out again while attending the Middle School unless you **DO NOT** want them to be able to purchase a la carte items. ***A new High School A la Carte Form must be filled out when entering 9th grade***

Please be reminded that a la carte items are sold separately at additional cost, regardless of whether or not the family qualifies for free or reduced meals.

-Students **must maintain a positive balance** in their Food/Beverage account to purchase a la carte items and **must have money in their account to cover the cost of a la carte items being purchased.**

-Students can check their account balance through **Skyward Family Access** or with any **cashier**.

-If you decide any time during the school year that you would like your child to have a la carte privileges, forms are available at the Middle School Food Service Office or Main Office.

****Students must return this form to the FOOD SERVICE OFFICE located next to the Middle School cafeteria or the MIDDLE SCHOOL MAIN OFFICE BEFORE they will be allowed to purchase A la Carte items. Forms need to be processed before A la Carte items can be purchased.**

A la carte items and prices are posted at the computer terminal.
